1 Your contract will be with pecialised Travel Concert Touring td (trading as ACFEA Tour onsultants) (company number 10713414), whose registered office is t Craven House, 40-44 Uxbridge toad, London, W5 2BS, telephone umber 020 8799 8360 and email ddress info@acfea.co.uk...

2 If you are booking a tour which icludes a flight, then you will be nancially protected for your tour (as etailed in clause 1.3 below), since we old an Air Travel Organiser's Licence ranted by the Civil Aviation Authority.)ur ATOL number is ATOL 12230. In ne unlikely event of our insolvency, ne CAA will ensure that you are not tranded abroad and will arrange to efund any money you have paid to us or an advance booking. For further formation, visit the ATOL website at ww.caa.co.uk, the CAA can be ontacted at 45-59 Kingsway, London VC2B 6TE.

OUR FINANCIAL PROTECTION

3 We provide financial protection for our tour as follows.

) When you buy a **flight-based tour** rom us, you will receive financial rotection for your flight-based tour nder our ATOL licence (detailed bove), and you will receive an ATOL ertificate. This lists what is financially rotected, where you can get iformation on what this means for ou and who to contact if things go *rrong*.

) We, or the suppliers identified on our ATOL Certificate, will provide you *i*th the services listed on the ATOL ertificate (or a suitable alternative). In ome cases, where neither we nor the upplier are able to do so for reasons f insolvency, an alternative ATOL older may provide you with the services you have bought or a suitable alternative (at no extra cost to you). You agree to accept that in those circumstances, the alternative ATOL holder will perform those obligations and you agree to pay any money outstanding to be paid by you under your contract to that alternative ATOL holder. However, you also agree that in some cases it will not be possible to appoint an alternative ATOL holder, in which case you will be entitled to make a claim under the ATOL scheme.

c) If we, or the suppliers identified on your ATOL certificate, are unable to provide the services listed (or a suitable alternative, through an alternative ATOL holder or otherwise) for reasons of insolvency, the Trustees of the Air Travel Trust may make a payment to (or confer a benefit on) you under the ATOL scheme. You agree that in return for such a payment or benefit you assign absolutely to those Trustees any claims which you have or may have arising out of or relating to the nonprovision of the services, including any claim against us, the travel agent. You also agree that any such claims may be re-assigned to another body, if that body has paid sums you have claimed under the ATOL scheme.

1.4 Financial protection for non-flight packages is provided to you by way of our membership with Protected Services (PTS), member Travel PTS provides a number 5726. financially secure and managed travel trust account service, ensuring that client money that we receive is protected from financial failure, in accordance with this clause. As members of PTS, when you buy a package tour from us that does not include a flight, then financial protection is provided by way of the PTS Travel Trust Account, which meets the requirements of the Package Travel and Linked Travel

Arrangements Regulations 2018 ("Package Regulations"). When you pay money to us by way of deposit and balance payments, your money is deposited in the PTS Travel Trust Account, managed by independent trustees through PTS. Until you have safely returned from your holiday, your money can only be used by us to make payments to suppliers of your holiday. Furthermore, each supplier payment made is protected through our supplier failure insurance so that if a supplier (eg, a hotel) were to fail financially, causing the holiday to be cancelled, your money remains protected.

2. TO MAKE A BOOKING

2.1 When you make a booking, you must sign and return the contract letter (which sets out details of your booking), accepting on your own behalf and on behalf of your group (for whom you have authority to accept) the terms of these Booking Conditions. You will also be required to pay a deposit of the amount notified to you at the time of booking and set out in your contract letter. A contract will exist when we issue our booking confirmation to you. Your contract with us will consist of these Booking Conditions, the contract letter, our Data Policy (available upon request and on our website at www.acfea.co.uk/) and the contents of the relevant literature and tour information.

2.2 Your contract with us is governed by English law and the non-exclusive jurisdiction of the English courts. You may however choose the law and jurisdiction of Scotland or Northern Ireland if you live there and wish to do so.

2.3 The balance of the price of your tour must be paid by the due dates specified in the contract letter, and as confirmed in your booking

confirmation. If the balance is not paid in time, we reserve the right to cancel your tour and retain your deposit. Please be aware that if you make your booking later than 10 weeks prior to departure, then you will be asked to pay the total price of the tour at the time of booking.

2.4 Payments of the price shall be made by you to us by debit or credit card, bank transfer or a cheque drawn on a UK bank account in favour of Specialised Travel Ltd. We make no charge if you pay by cheque, debit card or by electronic transfer. However, should you choose to make payment by commercial credit card, or you are a card holder outside of the EEA, we will make a charge equal to the cost to us of processing that payment using that payment card.

3. WHAT IS INCLUDED IN THE PRICE

3.1 We reserve the right to alter the prices shown in the contract letter, in accordance with these Booking Conditions. The current price of the tour is as notified to you before your contract is confirmed by us issuing our signed confirmation of the contract letter to you.

3.2 The tour price includes all elements of the tour programme set out in the booking confirmation and *may* include:

- air travel on scheduled or charter airline(s) specified, including local airport taxes and security charges (which are subject to change);
- accommodation at the hotel(s) detailed in the tour itinerary;
- transfers from airports or local railway stations to hotels by private motor coach;
- hotel service charges and local taxes;

- sightseeing tours, admission charges and guide services as detailed in the tour itinerary;
- concert arrangements as specified;
- services of an ACFEA Tour Consultants courier.

IB: If you have any special requests elating to diet, accommodation and o forth, these must be made known o us at the time of booking. We will o our best to comply with them but annot guarantee to do so (also see lause 13 below).

.3 The base price of your travel rrangements as set out in our ooking confirmation can vary due to hanges in: the price of carriage of assengers resulting from changes to ne costs of fuel or other power ources; the level of taxes or fees nposed by third parties including purist taxes, landing taxes or mbarkation or disembarkation fees t ports or airports; or exchange rate ariations. In accordance with ABTA's ode of Conduct and the Package equiations, we will absorb, and you vill not be charged for, any increase guivalent to 2% of the price of your ravel arrangements, which excludes ny amendment charges. You will be harged for the amount over and bove that. If this means that you ave to pay an increase of more than % of the price of your travel rrangements, you may either accept he changes (in which case you will be equired to pay the increased amount) r you may cancel the travel rrangements on behalf of the group nd receive a full refund of all moneys aid, except for our administration harges in respect of cancelling your ooking, in accordance with our ommitments to third parties up to ne date of such cancellation. Should ou decide to cancel, you must do so ithin the time period advised on confirmation by us of the change in price.

3.4 Should the price of your tour go down due to the cost of changes mentioned above, then any refund due will be paid to you. Please note that travel arrangements are not always purchased in local currency and some apparent changes have no impact on the price of your travel due to contractual and other protection in place.

3.5 The price of your tour was calculated based on exchange rates as listed in the Financial Times 'Guide to World Currencies' on the date of your contract letter.

3.6 Please note that in accordance with Air Navigation Orders, in order to qualify for infant status, a child must be under 2 years of age on the date of its *return* flight.

3.7 Where flights for the tour are booked by us, following the date when named individuals within the group are notified to us by you, if changes to those individuals are required and a confirmed flight has already been arranged for them, then we may or may not be able to alter that booking, depending on the terms and conditions of the airline (notified to you at the time of booking). If a flight can be transferred, then such a transfer would need to be accepted by the airline (together with payment in respect of any relevant transfer fees). If a flight cannot be transferred, then the cost of the ticket may not be refundable (depending on the terms and conditions of the airline, notified to you at the time of booking) and we cannot be liable in respect of any such cancellation fees.

3.8 If following receipt of your booking confirmation you wish to add or remove people in your tour group, then we will endeavour to make such

additions or changes. Please note that if you wish to add or remove people in your group, then the base price per person may change. We cannot be responsible if the additional people to the tour are not located in the same accommodation or if other elements of the tour programme differ for additional people where the same programme could not be reproduced for those additional people.

4. ALTERATIONS AND CANCELLATION BY YOU

4.1 If at any time after confirmation has been issued, you wish to change or modify the arrangements on the tour programme shown, we will do our utmost to make the changes provided that notification is received in writing from the person who signed the contract letter (i.e. the group leader), or persons authorised to act on behalf of the group. You should be aware that these costs could increase the closer to the departure date that changes are made, and you should contact us as soon as possible.

4.2 You may cancel the tour at any time provided that the cancellation is made by the group leader and is in writing. Cancellation would be for the whole tour group. As certain travel arrangements and bookings cannot be changed after confirmation, cancellation and amendments to a booking confirmed incur administration costs. We will also retain your deposit and in addition may apply cancellation charges as shown in the contract letter, or if no such cancellation details are set out in that letter, as per Clause 4.3 below.

4.3 The period before departure within which written confirmation is received and amount of cancellation charge shown as a percentage of the tour price:

91 days or over Deposit payments retained

90 days – day of departure: 100% of tour price

4.4 No refund will be given after the commencement of travel except at our discretion.

Please note that if the reason for your cancellation is covered under the terms of your insurance policy then you may be able to reclaim these charges.

4.5 You can cancel the tour without paying cancellation charges if the performance of your package or the carriage of passengers to your destination, is significantly affected by unavoidable and extraordinary circumstances. In such circumstances, we will arrange for your booking to be terminated and for you to receive a full refund. In assessing what is classified as unavoidable and extraordinary circumstances, we will observe advice provided by the UK Foreign, Commonwealth & Development Office

4.6 As your group booking allows you to confirm details of the individual travelling after you have booked, adjustments to the group details may be altered by you at any time up until the point we need details of group members for clarifying certain details and/or booking flights, etc. Once confirmed individuals have been provided to us, you can transfer booking arrangements to another person, who satisfies all the conditions that apply to this booking, by giving us notice in writing as soon as possible and no later than 7 days before departure. However, both you and the new person are responsible for paying all costs we incur in making the transfer, including (but not limited to) the cost of any transfer fees

harged by suppliers such as airlines *hose* flight tickets are nonransferable.

. ALTERATIONS AND ANCELLATION BY US

.1 It is a term of your booking that we re able to make changes to any spect of your booking. It is possible hat we may have to make changes to our tour arrangements (other than ne price) as these are planned many nonths in advance. Most of these hanges are insignificant and we will dvise you as early as possible. Flight mings and carriers detailed to you at he time of booking are subject to hange as a result of airline rocedures, which are beyond our ontrol. Flight timings in our booking onfirmation are for guidance only. ctual times will be given on your final inerary. We are required to advise ou of the actual carrier operating the ight, connecting flight (if any) and ransfer, which we will do in the final inerary. Any changes to the actual irline after you have received your nal itinerary will be notified to you as oon as possible and in all cases at heck-in or at the boarding gate. xamples of insignificant changes nclude alteration of vour utward/return flights by less than 12 ours, changes to aircraft type, hange of accommodation to another f the same or higher standard, hanges of carriers.

.2 If a major change becomes ecessary and we are constrained by ircumstances beyond our control to ignificantly alter any of the main haracteristics of the travel services nat make up your package you will ave the rights set out below.

Ve will inform you as soon as assonably possible if there is time efore departure. You will have the hoice of either, accepting the change f arrangements, accepting an offer

available of alternative travel arrangements of comparable or higher standard from us (where we offer one, we will refund any price difference if the alternative is of a lower value) or cancelling your tour and receiving a full refund of all monies paid. We will tell you the procedure for making your choice. Please read any notifications of changes carefully and respond promptly as if you do not respond to us within the timescales given your booking may be cancelled.

If you choose to accept a refund, we will pay compensation as detailed below except where the significant change is due to avoidable and extraordinary circumstances (as defined below).

5.3 We reserve the right in any circumstances to cancel your tour. For example, if a minimum number of people required for a particular travel arrangement, is not reached, we reserve the right to cancel the tour up to 120 days in advance. In this case we will provide a full refund of all moneys paid, but you will not be entitled to any compensation in such circumstances. In other circumstances we will not cancel your tour less than 60 days before the scheduled departure date except for reasons of unavoidable or extraordinary circumstances or your failure to pay the final balance.

If your tour is cancelled you can either have a refund of all monies paid or accept alternative travel arrangements of comparable or higher standard from us if we offer one (we will refund any price difference if the alternative is of lower value). In the event a refund is paid to you, we will pay compensation as detailed below except where the significant change is due to avoidable and extraordinary circumstances

5.4 If it is necessary to cancel your tour (except for reasons of unavoidable and extraordinary circumstances) or make a significant change after the date when payment of the balance becomes due and any significant changes are not acceptable to you, we will assess what payment of compensation to you is appropriate, given the nature of the tour arrangements and how close to the departure date the cancellation occurs. Please note compensation is not payable in the case of minor changes or where cancellation is due to unavoidable or extraordinary circumstances. The compensation offered does not exclude you from claiming more if you are entitled to do SO.

'Unavoidable and extraordinary circumstances' means unusual or unforeseeable circumstances beyond our control, the consequence of which could not have been avoided even if all reasonable measures had been taken, including (for example) but not limited to, war, riot, industrial dispute, terrorist activity and its consequences, natural or nuclear disaster, fire, weather adverse conditions. epidemics and pandemics. unavoidable technical problems with transport.

6. TRAVEL DELAY

We are unable to accept responsibility for, expenses incurred as a result of travel delay (please see insurance details for cover). For scheduled flights, the individual airline policy will apply.

7. SUPERVISION AND GROUP RESPONSIBILITIES

7.1 The group leader is officially in charge of the group and by signing the contract letter the group leader warrants that it shall, fully supervise the group at all times.

7.2 Where the group includes persons who are under 18 years old, the group leader further warrants that there shall be at least one responsible adult on duty at all times during the tour and that the group leader is responsible for the behaviour of all members of the group at all times. Any member of the group who is under 18 years old shall not be allowed to drink alcohol (unless with specific parental consent) and the group leader is responsible for ensuring that all members of the group comply with this. The group leader confirms that they have made the group aware of how they should behave during the tour before the tour starts.

7.3 You acknowledge that, if a concert is included as part of the tour programme detailed in the booking confirmation, the group is under an obligation to perform at such concerts detailed. The group leader shall be responsible for ensuring that the group performances are performed by the group. The group leader warrants that all information provided to us for the purposes of the concert performances shall take place and the group leader shall indemnify and keep indemnified ACFEA Tour Consultants against any losses, damages, costs or expenses it may incur as a result of delay or non-performance of the aroup.

7.4 Please note that the order of events on the tour itinerary is subject to alteration due to local circumstances, unscheduled closures etc. However, every effort will be made to include all elements of the programme during the tour or a suitable alternative which will be notified to you.

8. OUR LIABILITIES TO YOU

8.1 We accept responsibility for the proper performance of the travel

ervices included in your package that ou have booked with us. You must form us without undue delay of any ailure to perform or improper erformance of the travel services icluded in the package tour sold to ou by us. If any of the travel services icluded in your package are not erformed in accordance with the ontract. or any improperly erformed, by us or the travel service uppliers that we have arranged your ooking with, and this has affected enjoyment of your travel ne rrangements, you may be entitled to n appropriate price reduction or ompensation, or both. However, we ill not be liable where any failure to erform or improper performance of ne travel services is due to you or a nember of the group; or a third party nconnected with the provision of the ravel arrangements included in your ackage, or whether the failure is due o unavoidable and extraordinary ircumstances (as defined above), the onsequences of which could not ave been avoided even if all easonable measures had been taken.

.2 If an element within the itinerary is ancelled due to unavoidable and xtraordinary circumstances within ne month prior to the departure ate, we reserve the right to refund ne cost of the fees applicable to that lement only, if we receive a refund om the organisers or suppliers.

.3 We accept responsibility for the egligent acts and/or omissions of ur employees, agents or suppliers. ave for liabilities under clause 8.4 elow, our liability to you in all cases except where they lead to death, njury or illness), shall be limited to a naximum of three times the cost of ne original travel arrangements.

.4 Our liability to you will also be mited in accordance with and/or in n identical matter to:

 i) the contractual terms of the companies that provide the travel services that make up your tour package. These are incorporated into this booking contract; and

any relevant international ii) conventions (for example the Montreal Convention for travel by air, the Athens Convention for travel by sea, the Berne Convention for travel by rail and the Paris Convention for accommodation), which limit the amount of compensation that you can claim for death, injury, delay to passengers and loss, damage and delay to luggage. We are to be regarded as having all benefit of any limitation of compensation contained in these or any conventions. Travel by air or sea shall be subject to the general conditions of contract of the carrier (the contractual terms of the companies that provide the transportation for your travel arrangements are incorporated into this contract), subject to which the tickets are issued.

You can ask for copies of the travel service contractual terms, or the international conventions, from us.

8.5 If you, or any member of your group, are prevented from travelling on an aircraft because in the opinion of any person in authority at the airport you or they appear, by reason of intoxicating liquor or use of drugs, either to be unfit for travel or likely to cause discomfort or disturbance to other passengers, our responsibility for your journey, including any return flight thereupon ceases. You must accept responsibility for your proper conduct (and the conduct of those in your group) and we have the right to terminate our contract in circumstances of serious misconduct by you or any member of your group.

8.6 You may have rights in some circumstances to refunds and/or compensation from your airline in cases of denied boarding. cancellation, or delay to flights. Full details of these rights will be available at EU/UK airports and will also be available from airlines. However. please note that reimbursement in such cases does not automatically entitle you to a refund of the cost of your tour from us. Your right to a refund and/or compensation from us is set out in Clause 5. If any payments to you are due from us, then if the airline makes payment of these to you then such sum will be deducted from this amount. If your airline does not comply with such rules then you can complain to the Aviation Consumer Advocate Panel on O2O 7453 6888 or www.caa.co.uk

8.7 If it is impossible to ensure your as scheduled due return to unavoidable and extraordinary circumstances, we will bear the cost of necessarv accommodation, if possible, of equivalent category for a maximum of three nights. The limit doesn't apply to persons with reduced mobility and anv person accompanying them. pregnant women and unaccompanied minors, or persons in need of specific medical assistance, provided that you notified us of these needs at least 48 hours before the start of your tour.

NB. This clause does not apply to any separate contracts, that you may, enter in to for excursions or activities whilst on tour.

9. DATA PROTECTION POLICY

9.1 In order to process your booking and to ensure your travel arrangements run smoothly and meet your requirements, we need to use the information you provide to us, such as name, address, contact details and any special needs/dietary requirements, for each member of the group. Please see our Privacy Policy (available upon request and on our website at <u>www.acfea.co.uk</u>) for details of how we collect and process your personal data, and the personal data of those in your group.

9.2 We will only pass information on to persons responsible for part of your travel arrangements, such as airlines, hotels and transportation companies. The information may also be provided to security of credit checking companies, public authorities such as customs and immigration if required, or as required by law. The information passed to suppliers includes any sensitive information that you give to us such as details of any disabilities, dietary or religious requirements. If we cannot pass this information to the relevant suppliers whether in the EEA or not, we cannot provide your booking. In making your booking you consent to this information about you and the members of your party being passed on to the relevant persons, in accordance with our Privacy Policy.

10. PASSPORTS, VISAS AND HEALTH

10.1 You and your group's specific passport, visa and other immigration requirements are your responsibility and we do not accept responsibility for the validity of your passports or visas or for the refusal of visas by the Issuing Authorities. You should therefore confirm these with the relevant authorities. We shall not be liable for any loss, expense, cost, damage, injury, or loss of enjoyment suffered as a result, of such invalidity or loss, including any responsibility if you cannot travel because you have not complied with such requirements.

10.2 British Citizens require a passport. We will direct you to information about visas and health requirements. If any member of the group does not

old a valid UK passport, please iform us. We cannot be held esponsible for declined visas and ormal cancellation charges in espect of your booking will be levied hould this occur.

Please note that ome of the activities on our tours hay not be suitable if you have any hysical conditions, disability or educed mobility. In the interest of afety and comfort for the whole roup, all group members should be t enough to participate or Iternatively have persons available to ssist. We cannot be responsible in ne event that you or any or your roup are unable to enjoy all or any spects of the trip or cannot join ertain activities due to any special rrangements not being in place, or here elements of a trip are not uitable and we cannot provide you ith a refund in those instances. If you re taken ill whilst on the tour, we will nake every effort to ensure that you ave access to available local medical are and provide appropriate ssistance to you as your tour rganiser, however you and your next f kin remain responsible for nanaging all aspects of any medical mergency and ongoing care needs aising with your insurance provider s necessary.

12. COMPLAINTS

12.1 If you have a problem with your tour please inform the relevant supplier and our ACFEA Tour Consultants courier, if applicable, who will endeavour to put things right quickly. If your complaint cannot be resolved locally, we will ask you to make a report in addition to contacting us as soon as practically possible. Please follow this up within 28 days of your return home by writing to us giving your tour name and all other relevant information. Please keep you letter concise and provide all relevant information. If you fail to follow the requirement to report your compliant during your holiday, we will have been deprived of the opportunity to investigate and rectify it and this may affect your rights under this booking.

12.2 It is unlikely that you will have a complaint that cannot be settled amicably between us. However, disputes arising out of or in connection with our contract with you which cannot be amicably settled, may (if you so wish) be settled by way of an alternative dispute resolution procedure.

13. SPECIAL REQUESTS

Any special requests made by you are noted and we do our very best to comply with these wherever possible. However, although we do make every effort to meet your requirements, we cannot unfortunately give a quarantee.

14. EXCURSIONS

Excursions or other tours that you or any member of your group may choose to book or pay for whilst you are on tour are not part of your package tour provided by us. For any excursion or other tour that you or any member of your group book which does not form part of your package tour with us, your contract will be with the operator of the excursion or other tour and not with us. We are not responsible for the provision of the excursion or other tour or for anything that happens during, the course of, its provision by the operator.

15. SEVERABILITY

If any part of these Booking Conditions is held to be invalid, unreasonable, or unenforceable, such portion(s) shall be deemed as severable from these Booking Conditions and the remainder of these Booking Conditions shall remain in full force and effect and enforceable.

16. TRAVEL INSURANCE

It is a condition of these Booking Conditions and your contract with us that you and all members of your group have comprehensive travel insurance cover.

Your travel insurance should be appropriate for all activities included in your tour, including (but not limited to) taking part in any group activity, concert or other performances, together with insurance of any instruments or equipment that the group are transporting.

17. ASSISTANCE

If you're in difficulty whilst on the tour and ask us to help we will provide appropriate assistance, in particular by providing information on health services, local authorities and consular assistance; and helping you to find alternative arrangements and any necessary phone calls/emails. You must pay any costs we incur, if the difficulty is your fault.
